Indemnity form

I understand that the program involves physical activities and acknowledge that my child,

(Full name & surname of potential swimmer)

is physically able to take part in this program. In the event of any physical injury or problem I will inform the instructor immediately and my child will be excused from lessons.

I understand that my child will not be accepted to participate in the program, should the instructor be aware of any reason that may be dangerous to his / her well being or health.

I am aware that injuries may occur and will not hold the instructor responsible therefore, unless negligence can be proven.

I waive any claim against Tiny Bubbles or any of its employees in the event of any damage which may arise in connection with tuition, theft, loss of life or bodily injury or any other course whatsoever.

The waiver is unconditional and is given both in my personal capacity and in my capacity as father / mother or natural or legal guardian of any minor concerned.

I understand that all fees must be paid in advance **whether my child attends lessons or not**, in order for him to keep his place at Tiny Bubbles. Once a week from Aug to Dec = 15 Lessons. Twice per week from Aug to Dec = 30 Lessons.

Three (One lesson per week) or Six (Two lessons per week) of thirty minutes each are guaranteed per month. Other lessons will be carried over to short months or months with public or school holidays.

Full Swimming Fees are payable in advance from the 1st August until 1st of May (Including school holidays and December)

Fees **paid in advance** are not refundable.

There is a holding fee of R100 per month during June and July to ensure my child keeps his swimming space when the new swim season starts again.

Swimming fees will be reviewed annually and will take effect in August each year.

A one month **WRITTEN NOTICE** (No Whatsapps / Sms's) have to be given when you wish to terminate the contract. The child can still swim during the Notice Month.

A R45 late payment penalty will be added to all accounts not paid in full before the 5th of each month. If you get paid weekly or every second week, you can make alternative arrangements accordingly.

Payments can be made cash or via EFT

The contract will be terminated should these terms & conditions not be met or if your child is difficult to handle under supervision.

Terms and Conditions

Enrolment:

1. An annual registration fee is payable on enrolment of all students. (R120 for new enrolments & R80 for existing students)
2. A **Contract, Indemnity form, Terms and Conditions** and **Permission to Transport** have to be completed, signed and either handed in or emailed to: tinybubbleswimschool@gmail.com; before any lessons will commence.
3. Swimming fees are payable in advance and due on the first of every month.
4. A R45 late payment penalty will be added to all accounts not paid in full before the 5th of each month.
5. If fees are outstanding or not paid in full by the fifth of each month, the student will be suspended.
6. Fees can be paid cash or by EFT. Cash must be put into a sealed envelope and marked clearly: Name & Surname of swimmer. Amount & date. Place the sealed envelope in the postbox at the Swimming School.
7. Full fees are payable from 1 August to 1 May whether lessons are attended or not and a holding fee of R100 for the Winter months (June & July).

Lesson Structure:

8. Students can choose: One 30 minute lesson per week (Three per month) or Two 30 minute lessons per week (Six per month) The extra lessons per month will be carried forward to months that have less than three / six lessons due to school or public holidays.
9. There will be no lessons during Government School Holidays and Public holidays.
10. **If for any reason a swimmer fails to attend a lesson, that lesson will be forfeited.**
11. The instructor reserves the right to cancel or change a lesson due to unforeseen circumstances. (Eg. Bad weather or lightning)
12. In case of the above (11) a make-up lesson will be arranged at a time suitable to both parties.
13. Regular attendance and further practice is advisable for best results.
14. Students must be in time for lessons. No additional time before or after lessons will be given.

Discipline

15. Correct behavior in and around the pool is very important for safety.
16. Explain and discuss the swimming pool rules with your child regularly. (On the website)
17. Undisciplined children will be dismissed. Inappropriate behavior endangers everybody.
18. A child not listening to the teacher or misbehaving in the pool during a lesson will get "Time Out" The child will have to get out of the pool and go sit on the Red chair and watch the lesson from outside the pool.
19. When the child has to be "disciplined" on the Red Chair for three times in a short period, that child will be given Notice.
20. Children will be buckled in on the Tiny Bubbles Bus.
21. Children take only their swimming bag to the Swim School, no School bags, as they will be returned to School.
22. No eating or drinking on the Bus.
23. If a child is a continuous distraction in the Bus, transport will be terminated.

Notice

24. One month written notice is due by either party under normal circumstances.
25. A Whatsapp or Sms will not be accepted as a Written Notice.
26. A Written Notice has to be Emailed or handed to the Owner / Manageress.
27. Undisciplined children does not count as Normal circumstances
28. Payment for the Notice month is due by the first of that month, whether attended or not.

Damage

29. Any damage to the facility / equipment or property of "Tiny Bubbles Swim School" caused by a child or anybody accompanying the child will be for the account of the parent / guardian.
30. In the event of irreparable damage to any of the above (23), the parent / guardian will be required to replace such, within seven days of written notice by the owner / teacher / instructor.

- 31. Damaged facilities or equipment is to be replaced at the current value, make and model etc.
- 32. Failure to pay any tuition fees or damages will result in legal action. The parent / guardian will be liable for all legal costs incurred in the recovery of fees / damaged property or equipment.
- 33. This is a legal and binding contract and will commence on the day of joining.

Terms & condition:

1. I must be informed well in advanced in the case of **absence** from school or if for any reason I should **not pick up** the child/children from school.
2. Please ensure your child/children are punctual especially because any delay will cause an inconvenience for the other children in the transport. Remind them in the morning that "today" is swimming and you will be fetched from school for swimming lessons.
3. Make sure your child's swimwear, towel & swim cap is packed in a separate bag. An extra set of clothes for after swimming is also advisable and a warm jacket to put on after swimming on cooler days.
4. Please be advised that all necessary precautions for your child's safety will be made, but Tiny Bubbles and its employees, will not be responsible or liable for any injuries / death in case of an accident.
5. The school(Mentioned herein) where the child is transported from & it's staff will also not be liable for any injuries or death in case of an accident.
6. Payments are made in advance for the month to follow, with the swimming fees.
7. One month written notice is required before termination of this contract. (No Whatsapps / Sms's)
8. Payments must be made irrespective if the child/children attend school or not.
9. Full payments are required for each swimming month of the year irrespective of school holidays. (Aug to May)
10. If the child is not at school (Private School Holidays) parents or caregivers must arrange to bring children to the Swim School on their own accord.
11. All payments must be made electronically into the Tiny Bubbles Swim School Account or cash, as per invoice.
12. All fares will be reviewed annually. (August)
13. I can terminate the contract should these terms & conditions not be met or if your child or children are undisciplined during transport.
