## **Indemnity form**

I understand that the program involves physical activities and acknowledge that I,

am physically able to take part in this program. In the event of any physical injury or problem I will inform the instructor immediately and will excuse myself from lessons.

I understand that I will not be accepted to participate in the program, should the instructor be aware of any reason that may be dangerous to my wellbeing or health, or to any other swimmer or Staff member.

I am aware that injuries may occur and will not hold the instructor responsible, unless negligence can be proven.

I will inform the instructor of any illness or condition myself or a family member has that can be contagious or a risk to any other parent or child I may come into contact with. In such a case I or member/s of my family are not permitted to come to the swim school, until a medical practitioner gives clearance.

I waive any claim against Tiny Bubbles or any of its employees in the event of any damage which may arise in connection with tuition, theft, loss of life or bodily injury or any other course whatsoever.

The waiver is unconditional and is given both in my personal capacity and in my capacity as father / mother or natural or legal guardian of any minor concerned. (In case of child under 18)

I understand that all fees must be paid in advance **whether my child attends lessons or not**, in order for him / her to keep swimming at Tiny Bubbles. **(A Makeup lesson will ONLY be arranged if the child is unfit to swim due to injury or sickness and a Doctor's Letter is handed in)**

Three (One lesson per week) or Six (Two lessons per week) of Forty-five minutes each are guaranteed per month. Other lessons will be carried over to short months or months with public or school holidays.

Full Swimming Fees are payable in advance from the 1<sup>st</sup> August until 1<sup>st</sup> of June **(Including school holidays and December)**

### **Fees paid in advance are not refundable**

There is a holding fee of R120 per month during (June) and July to ensure you keep your swimming space for the new season. When we Complete the June lessons, before Winter & should you swim until we close, full fees are payable.

Should you fall ill or sustain an injury and cannot continue swimming or due to any government ruling a R120 holding fee per month will ensure your space until you or we are able to swim again.

Swimming fees will be reviewed annually and will take effect in August each year.

A one month **WRITTEN NOTICE** has to be given when you wish to terminate the contract. You can still swim during the Notice Month.

A R45 late payment penalty will be added to all accounts **not paid in full before the 5<sup>th</sup> of each month**. If you get paid weekly or every second week, you can make alternative arrangements accordingly.

Payments can be made cash or via EFT.

The contract will be terminated should these terms & conditions not be met or if the potential swimmer is difficult to handle under supervision.

## Terms and Conditions

### Enrolment:

1. An annual registration fee is payable on enrolment of all students. (R120 for new enrolments & R80 for existing students)
2. A **Contract, Indemnity form and Terms and Conditions** have to be completed, signed and either handed in or emailed to: [tinybubbleswimschool@gmail.com](mailto:tinybubbleswimschool@gmail.com); before any lessons will commence.
3. Swimming fees are payable in advance and due on the first of every month.
4. A **R45 late payment penalty** will be added to all accounts not paid in full before the 5<sup>th</sup> of each month.
5. If fees are outstanding or not paid in full by the fifth of each month, the student will be suspended.
6. Fees can be paid cash or by EFT. Cash must be put into a sealed envelope and marked clearly: Name & Surname of swimmer. Amount & date. Place the sealed envelope in the postbox at the Swimming School.
7. Full fees are payable from 1 August to 1 June whether lessons are attended or not and a holding fee of R120 for the Winter months (July).

### Lesson Structure:

8. Students can choose: One 45 minute lesson per week (Three per month) or Two 45 minute lessons per week (Six per month) The extra lessons per month will be carried forward to months that have less than three / six lessons due to school or public holidays.
9. There will be no lessons during Government School Holidays (see online Calendar) and public holidays.
10. **If for any reason a swimmer fails to attend a lesson, that lesson will be forfeited.**
11. The instructor reserves the right to cancel or change a lesson due to unforeseen circumstances. (E.g., Bad weather or lightning)
12. In case of the above (11) a make-up lesson will be arranged at a time suitable to both parties.
13. Regular attendance and further practice are advisable for best results.
14. Students must be in time for lessons. No additional time before or after lessons will be given.

### Discipline

15. Correct behavior in and around the pool is very important for every body's safety.
16. Swimming pool rules are on the website / copies at the Swim School., please adhere to all rules
17. Undisciplined Swimmers will be dismissed. Inappropriate behavior endangers everybody.
18. A Swimmer not listening to the teacher, disrespecting or misbehaving in the pool during a lesson will get "Time Out"

### Notice

19. One month written notice is due by either party under normal circumstances.
20. A WhatsApp or SMS will not be accepted as a Written Notice.
21. A Written Notice has to be Emailed or handed to the Owner / Manageress.
22. Undisciplined Swimmers do not count as Normal circumstances
23. **Payment for the Notice month is due by the first of that month, whether attended or not.**

### Damage

24. Any damage to the facility / equipment or property of "Tiny Bubbles Swim School" caused by a student or anybody accompanying the student will be for the account of the adult student or the parent / guardian of a minor student,

25. *In the event of irreparable damage to any of the above (23), the adult student or parent / guardian of a minor will be required to replace such, within seven days of written notice by the owner / teacher / instructor.*
26. *Damaged facilities or equipment is to be replaced at the current value, make and model etc.*
27. *Failure to pay any tuition fees or damages will result in legal action. The adult student or parent / guardian of a minor will be liable for all legal costs incurred in the recovery of fees / damaged property or equipment.*
28. *This is a legal and binding contract and will commence on the day of joining.*
