We do 3 or 6 lessons per month for the 12 months of the year (“Swimming” Months Overlap)

You will be added to a WhatsApp group where parents will be kept up to date with all.

Should your child be ill and cannot continue swimming for a month or more, please supply a Doctor’s Letter and pay the holding fee to keep his / her swimming space.

Swimming bags can be ordered at R385 each. This is a rucksack or Beach bag with towel inside and the swimmer’s name embroidered on the front of the bag.

If you require transport for your child from his Pre-School, School or Aftercare, (Within our service area) please ask for the forms and it will be emailed to you. (There have to be at least 5 children at his / her particular school to arrange transport)

Indemnity form

I understand that the program involves physical activities and acknowledge that my child,

(Full name & surname of potential swimmer)

is physically able to take part in this program. In the event of any physical injury or problem I will inform the instructor immediately and my child will be excused from lessons.

I understand that my child will not be accepted to participate in the program, should the instructor be aware of any reason that may be dangerous to his / her wellbeing or health or to any other Swimmer or staff member.

I am aware that injuries may occur and will not hold the instructor responsible, unless negligence can be proven.

I will inform the instructor of any illness or condition my child or a family member has that can be contagious or a risk to any other parent or child he / she may come into contact with. In such a case the swimmer and family are not permitted to come to the swim school, until a medical practitioner gives clearance.

I waive any claim against Tiny Bubbles or any of its employees in the event of any damage which may arise in connection with tuition, theft, loss of life or bodily injury or any other cause whatsoever.

The waiver is unconditional and is given both in my personal capacity and in my capacity as father / mother or natural or legal guardian of any minor concerned.

I understand that all fees must be paid in advance **whether my child attends lessons or not**, in order for him / her to keep swimming at Tiny Bubbles. **(A Makeup lesson will ONLY be arranged if the child is unfit to swim due to injury or sickness and a Doctor's Letter is handed in)**

Three (One lesson per week) or Six (Two lessons per week) of thirty minutes each are guaranteed per month. Other lessons will be carried over to short months or months with public or school holidays.

Full Swimming Fees are payable in advance for each month of the year. **(Including school holidays and December)**

Fees paid in advance are not refundable

Holding Fee

Should your child fall ill or sustain an injury and cannot continue swimming or due to any government ruling, a R120 holding fee per month will ensure your child’s space until he / she (or we) are able to swim again.

Babies and Toddlers (under 4) may go on hold during the Winter months, there swimming space will be kept until it gets warmer again.

We do not swim during July, but all July lessons will be completed by the end of June. An out of water Winter program will be available during July.

Fees

Swimming fees will be reviewed annually and will take effect in **Spring after the Winter Season.**

A one month **WRITTEN NOTICE** (No WhatsApp’s or SMS’s) have to be given when you wish to terminate the contract. The child can still swim during the Notice Month.

Fees for the Notice month has to be paid in advance by the first of the month and not later than the 5th.

A R45 late payment penalty will be added to all accounts **not paid in full before the 5th of each month.** If you get paid weekly or every second week, you can make alternative arrangements accordingly.

Payments can be made **Cash.** (No cash deposits please, as banking fees are too high) **or via EFT**

There is a post-box in the swimming area for CASH payments. Cash payments must be marked clearly.

The contract will be terminated should these terms & conditions not be met or if your child is difficult to handle under supervision.

Terms and Conditions

Enrolment:

1. An annual registration fee is payable on enrolment of all students. (R120 for new enrolments & R80 for existing students)
2. A **Contract, Indemnity form and Terms and Conditions** have to be completed, signed and either handed in or emailed to: tinybubbleswimschool@gmail.com; before any lessons will commence.
3. Swimming fees are payable in advance and due on the first of every month.
4. A **R45 late payment penalty** will be added to all accounts not paid in full before the 5th of each month.
5. If fees are outstanding or not paid in full by the fifth of each month, the student will be suspended.
6. Fees can be paid cash or by EFT. Cash must be put into a sealed envelope and marked clearly: Name & Surname of swimmer. Amount & date. Place the sealed envelope in the postbox at the Swimming School.
7. Full fees are payable from 1 August to 1 June whether lessons are attended or not and a holding fee of R120 for the Winter month (July).

Lesson Structure:

8. Students can choose: One 30 minute lesson per week (Three per month) or Two 30 minute lessons per week (Six per month) The extra lessons per month will be carried forward to months that have less than Three / Six lessons due to school or public holidays.
9. There will be no lessons during public holidays. There will also be one week holiday during Government School holidays & one during Private School Holiday.
10. **If for any reason a swimmer fails to attend a lesson, that lesson will be forfeited.**
11. The instructor reserves the right to cancel or change a lesson due to unforeseen circumstances. (Eg. Bad weather or lightning) A makeup lesson will be arranged in the case of (11)
12. A makeup lesson will be arranged Only when a medical certificate can be presented.
13. **Regular attendance and further practice at home are advisable for best results.**
14. Students must be in time for lessons. No additional time before or after lessons will be given.

Discipline

15. Correct behavior in and around the pool is very important for everybody's safety.
16. Explain and discuss the swimming pool rules with your child regularly. (On the website / Copies at Swim School)
17. Undisciplined children will be dismissed. Inappropriate behavior endangers everybody.
18. A child not listening to the teacher or misbehaving in the pool during a lesson will get "Time Out"
The child will have to get out of the pool and go sit on the **red chair** and watch the lesson from outside the pool.
19. When the child has to be "disciplined" on the **Red Chair** for three times in a short period, that child will be given Notice.

Notice

20. One month written notice is due by either party under normal circumstances.
21. A WhatsApp or SMS **will not be accepted** as a Written Notice.
22. A Written Notice has to be Emailed or handed to the Owner / Manageress.
23. Undisciplined children do not count as Normal circumstances
24. Payment for the Notice month is due by the first of that month, whether attending or not.

Damage

25. Any damage to the facility / equipment or property of "Tiny Bubbles Swim School" caused by a child or anybody accompanying the child will be for the account of the parent / guardian.

- 26. *In the event of irreparable damage to any of the above (24), the parent / guardian will be required to replace such, within seven days of written notice by the owner / teacher / instructor.*
- 27. *Damaged facilities or equipment is to be replaced at the current value, make and model etc.*
- 28. *Failure to pay any tuition fees or damages will result in legal action. The parent / guardian will be liable for all legal costs incurred in the recovery of fees / damaged property or equipment.*
- 29. *This is a legal and binding contract and will commence on the day of joining.*
